What information is needed and why we collate this information.

We collect information in the following ways:

## Information you give us voluntarily.

When you make any purchases, enquiry, feedback or register an account for product warranty and to use our products and services etc., we will require your personal information such as your name, email address, ship-to address and telephone number; namely for salutation, non-marketing and marketing communication, verification and executing the delivery of goods and services.



#### Information we get from your use of our products and services.

#### 1.2 How we use the Information we collect

#### 1.3 Information we share

We do not share personal information with companies, organizations and individuals outside of Bridgetek Pte Ltd and there is no external processing of your information provided to us, unless one of the following circumstances applies:

  - Establishing our legal rights or defending against legal claims.
  - o Address or otherwise prevention of security or technical issues.
